2. ELIGIBILITY REQUIREMENTS:
  - You must be at least 21 years of age by September 15, 2008.
  - You must be either:
    - a) a legal resident of the U.S. or
    - b) able to obtain the necessary visa or waiver to allow you to stay in the U.S for the filming of the program
  - You must not have had gross sales of more than \$100,000/year as a fashion designer.
  
3. Please fill out the enclosed application legibly.
  
4. Use dark colored ink.
  
5. Answer all questions honestly and accurately to the best of your ability.
  
6. Please note that if you move on to be a semi-finalist in the candidate selection process (as defined as an officially selected potential contestant for Project Runway; Season 6 (the "Program")), we will require you sign Producer's standard paperwork which shall include, but not be limited to, a participant waiver/release agreement, confidentiality form and statement of veracity and the right of Producer to conduct legal, physical, and medical background checks. If you are selected as a semi-finalist you will need to travel at your own expense to your closest semi-final location for an in-person interview and assessment of your designs. Cities in which we may conduct semi-final interviews include (but are not limited to): New York, Los Angeles, Chicago, Atlanta, Dallas, Miami, Seattle, and San Francisco. The semi-finals are currently scheduled to take place between July 21 and August 21, 2008.
  
7. Please write only on the printed side of the paper. Feel free to attach additional sheets as necessary. DO NOT turn the page over and write on the back.
  
8. Please include the following photos (digital images preferred- if digital, please include both good-quality printouts of your photos and a CD or DVD of the digital images):
  - Two recent photos of yourself: one full-length shot and one close-up of your face.
  - A "virtual portfolio" of your work (include as many of the following as apply):
    - a) photos of at least three but no more than ten of your completed designs (preferably shown on a model or dress form), marked with their dates of completion; include front, side, and back views; show a variety of looks for both day and evening if you have them.
    - b) images of detail work (e.g. beading, ruching, pleating, knitting, crochet) that you have produced, if applicable.
    - c) images of your patterns if you work from them; some should be for the outfits pictured.
    - d) images of your sketches.

9. You must staple a copy of your driver's license or other government-issued ID (passport, state ID card, etc.) to the back of the packet.

10. You must include a 3 to 5 minute personal video, on mini-DV or DVD ONLY. No other formats will be accepted. Your video should consist of the following: a personal introduction, telling us who you are and giving us an overview of your life; a summary of your design goals and achievements; why you need Project Runway to achieve your goals; and anything else you think we need to know. Relax, have fun, and let your personality shine through. Please remember that this is a movie starring you; you should be in front of the camera talking to it, not acting as the director behind the scenes. You are not being judged on the professionalism of this video, but please double-check before sending it to us that a)we can hear you (i.e. the tape/camera had functional sound when you filmed) and b) we can see you (i.e. there was enough light while you were filming that we can see you clearly).

You should send all application materials in one package **ASAP**. **ALL APPLICATIONS MUST BE RECEIVED IN OUR OFFICES NO LATER THAN WEDNESDAY, JULY 9.** NO LATE APPLICATIONS WILL BE CONSIDERED. NO PERSONAL DELIVERIES WILL BE ACCEPTED. **PLEASE NOTE: WE ARE NOT ABLE TO RETURN APPLICATION MATERIALS TO YOU, AND THAT YOU SHOULD CAREFULLY REVIEW THE WAIVER AND RELEASE FORMS AT THE END OF THIS APPLICATION.**

## **ELIGIBILITY REQUIREMENTS AND RELEASES (the "Agreement")**

As used herein, "Producer" shall include Runway Productions, Inc., and The Weinstein Company LLC, and each of their respective parents, subsidiaries, and affiliates, and each of their respective officers, directors, shareholders, employees, agents, representatives, successors, licensees and assigns.

1. You, the undersigned, must be (a) a legal resident of the U.S. and able to legally travel to any foreign country in connection with your participation in the Program, or (b) able to obtain the appropriate visa or waiver to enable you to stay legally in the United States to participate in the Program and be able to legally travel to any foreign country in connection with your participation in the Program.
2. You must not have had gross sales of more than \$100,000 per year as a fashion designer.
3. You must have a valid passport that will be in full force and effect beginning no later than June 1, 2008 and continuing through December 31, 2009.
4. You must be at least 21 years of age as of September 15, 2008.
5. You must not be a candidate for public office and must agree not to become one until after one (1) year after the initial exhibition of the episode(s) of the Program in which you appear, if selected as a contestant.
6. You may not participate in the Program if your participation would create impropriety or the appearance of impropriety as determined by Producer and/or Lifetime Entertainment Services ("Network"), in their sole discretion. In making this determination, Producer and Network will consider whether you or any member of your immediate family or anyone living in your household is or has been within the last two (2) years an employee, officer, director, representative or agent of any of the following:
  - (a) Network or any television production company, network, station or distributor owned and/or operated by Network their respective licensees, successors, assignees, parents, subsidiaries, or affiliated entities and each of their respective officers, directors, agents, representatives, employees, successors, assignees, and licensees;
  - (b) Producer, Miramax Film Corp. or any other person or entity involved in the development, production, distribution or other exploitation of the Program or any variation thereof;
  - (c) Any current or potential sponsor of the Program or its advertising agency; or
  - (d) Any person or entity supplying prizes or other services to the Program.

In addition, Producer and Network reserve the right to render ineligible any person whom either of them determines, in their sole discretion, is sufficiently connected with the production, administration, judging, or distribution of the Program, such that his or her participation in the Program could create the appearance of impropriety. Such decisions are final and are not subject to challenge or appeal.

7. If you are selected as a potential contestant, you must execute waivers and release agreements, including, but not limited to, a participant agreement and release and other agreement(s) as required by the Producer or the Network, or any of their licensees, successors or assigns.

8. You will need to be available to the production as follows: The shooting of the Program is currently scheduled to be done in three (3) stages -- the initial stage, the middle stage, and the final stage. The initial stage will last approximately four (4) weeks and will be shot in Los Angeles or such other location(s) (which may be domestic and/or international) as Producer designates in its sole discretion. You will need to be willing to travel to Los Angeles, CA (or such other city(ies) (which may be domestic and/or international) that Producer designates in its sole discretion) and live in a Los Angeles based home (or a home(s) based in another city(ies) (which may be domestic and/or international) that Producer designates in its sole discretion) with other contestants, for all or part of the initial stage. The middle stage, if you progress that far, will involve shooting in your home and/or office during the period between the initial stage of the contest and the final stage. The final stage may be shot in New York City during Fall or Spring Fashion Week and, if you progress to the final stage, you will need to be available to be in New York City for approximately one (1) week, or such other location (which may be domestic and/or international) as Producer may designate in its sole discretion. You will need to be available for pre-production and post-production activities. Furthermore, you may be separated from the other members of your family and friends for some or all of this time.

9. If selected for further consideration as a so-called "semi finalist", you must be willing to submit medical information to the production, and you must be willing to submit to a medical examination, psychological examination, and background check to the maximum extent permitted by law if and to the extent required by Producer and/or the Network.

10. You hereby give the following representations, warranties, acknowledgements, consents and releases:

(a) By signing below, I, the undersigned, hereby represent, warrant, acknowledge, and agree that: (i) I have read and I meet and agree to be bound by the eligibility requirements; (ii) I have completed this application honestly and accurately; (iii) I understand that if any of the information in this application is found to be false or incomplete, this will be grounds for dismissal from the contestant selection process and/or from the contest and/or from the Program if I have been selected to participate in the contest and Program; (iv) even if I meet the eligibility requirements, Producer has no obligation to interview me and/or select me as a contestant; (v) I agree to keep strictly confidential all information about the Program, the Network and the Producer, that I acquire during the contestant selection process and during my participation in the Program (if applicable); (vi) my voice, actions, and likeness will be recorded as a part of this application and contestant selection process, and I understand that Producer may, but is in no way obligated to, actually use such recordings within the Program or in any other manner; (vii) even if I am selected as a contestant, Producer has no obligation to produce the Program or conduct the contest, and Producer and/or Network have no obligation to exhibit, broadcast or otherwise exploit, the Program, even if the contest is conducted and the Program is recorded or filmed; (viii) all decisions by Producer concerning selection of the contestants are final and not subject to challenge or appeal; and (ix) Producer has no obligation to return any materials submitted by me as part of the contestant selection process whether or not I am selected as a contestant, and Producer may, but is in no way obligated to, use any such materials in the Program or in any other manner.

(b) By submitting this application, I hereby consent to the recording, use and reuse by Producer and Network, and any of their respective licensees, successors, assignees, parents, subsidiaries, or affiliated entities, and each of their respective employees, agents, representatives, officers and directors of my voice, actions, likeness, name, appearance, biographical material, and any information or Materials (as defined below) contained in, derived from or obtained in connection with my application to be a contestant in the Program, including, without limitation, any video, recordings or still pictures of me taken during the contestant selection process, or contained in any material submitted by me in connection with my application (collectively "Likeness"), as edited, altered, or modified by the Producer or by any of the other Releasees (as defined in Paragraph 10 below), in any and all media, now known or hereafter devised, worldwide, in perpetuity, in and in connection with the Program or any other work. I agree that the Releasees or any of them may use all or any part of my Likeness, and may alter or modify it regardless of whether or not I am recognizable. I further agree that the Producer exclusively owns all right, title, and interest (including, without limitation, all copyrights) in and to any video, recordings and still pictures of my portfolio and/or of my designs, including, but not limited to, articles of clothing, and any other materials that I have provided or may provide in connection with this application, the Program and the contestant selection process and in and to any video, recordings and still pictures taken during the contestant selection process of any materials provided by me, including, but not limited to, my portfolio and/or my designs, including, but not limited to, articles of clothing (collectively, the "Materials"), including, without limitation, the right to edit, alter or modify the Materials and to use all or part of the Materials and my Likeness in any and all media, now known or hereafter devised, worldwide, in perpetuity. Without in any way limiting the foregoing, if I perform or include any music (other than music supplied to me by Producer) in connection with my application or the Program, I represent and warrant that I own all rights to such music, and I grant Producer and Network the right to record, reproduce and publicly perform, and use and/or market for profit, any such music in and in connection with the Program or any other work. Without in any way limiting the waivers and releases set forth herein, I waive any claims to royalties of any kind, whether accruing now or in the future, from Producer or their licensees for the use of any such music, including, without limitation, any applicable copyright, public performance, mechanical and synchronization royalties. I further agree that Producer and its licensees may use my Likeness and the Materials in connection with any promotion, publicity, marketing or advertisement. I grant the rights hereunder whether or not I am selected to participate in the Program in any manner whatsoever. I understand that I will not be provided any compensation including but not limited to financial compensation for granting Producer and Network these rights or for signing this application and consenting to the releases contained herein, the consideration for which shall be the opportunity to apply for, and potentially participate on, the Program.

(c) I agree to take, at Producer's expense, any further action, in writing (including, without limitation, execution of affidavits and/or other documents), requested by Producer to effect, perfect or confirm Producer's and Network's rights in the Materials and my Likeness, including without limitation, the rights to use, modify, reproduce, publish, perform, display, distribute, make derivative works of and otherwise commercially and non-commercially exploit the Materials and my Likeness in perpetuity and throughout the universe, in any manner or medium now existing or hereafter developed, without separate compensation to me or any other person or entity.

(d) I hereby authorize Producer and any person or entity designated by Producer to investigate, access and collect information about me, about any of the statements made by me in my

application, my participant agreement (if any), any supporting documents and any other documents that I have signed or provided or do sign or provide in connection with my application to be selected as a contestant in the Program, or any other written or oral statements I make in connection therewith. I irrevocably authorize Producer and/or Network and any person or entity designated by Producer and/or Network to secure information about me and my experiences from my current and former employers, associates, friends, family members, educational institutions, government agencies, credit reporting agencies, and any references that Producer and/or Network deem relevant in their sole discretion and I irrevocably authorize such parties to provide information concerning me. I hereby unconditionally and irrevocably release and forever discharge Producer and Network, the persons or entities designated by Producer and/or Network, and all such parties and persons from any and all liabilities arising out of or in connection with any such investigation. I specifically authorize investigation of my employment records, medical records, and government records, including but not limited to my motor vehicle records, military records, criminal records and credit and/or consumer report(s). I acknowledge and agree that any such information obtained by Producer and/or Network or by any person or entity designated by Producer and/or Network pursuant to this paragraph or otherwise may be used for purposes of selecting contestants in the Program, and may be described or otherwise related in and in connection with the Program.

(e) I hereby authorize Producer and any person or entity designated by Producer to conduct psychological and physical examinations of me as required by Producer or Network. I further authorize the individuals conducting such examinations of me to disclose to Producer and their representatives all information about me obtained in connection with such examinations, and authorize Producer to utilize such information in selecting contestants for the Program. Additionally or in the alternative (in Producer's and/or Network's sole discretion), I will provide Producer with certification from my personal physician stating that I am physically fit and have no medical condition that would prevent me from participating in the Program.

(f) I understand that the contestant selection process will involve subjective decisions made by certain individuals selected by Producer and/or Network in their sole discretion, who may include, without limitation, fashion designers, Project Runway contestants from Cycles one through five, and Tim Gunn (the "Panelists"). I understand that the Panelists may make casting recommendations to the Producer and Network but that all casting decisions will be made by the Producer and Network in their sole discretion. I further understand that the Panelists, the Network, Producer and/or other persons or entities may be acquainted with or have some familiarity with some or all of the applicants to varying degrees. I further understand that in addition to regional and international auditions for the Program, which are open to all applicants who meet the Program's eligibility requirements, there may be "invitational" auditions, to which certain applicants are invited to audition. I understand and agree that all contestant selection and elimination decisions shall be final and binding on me in all respects, and shall not be subject to challenge or appeal.

11. **RELEASE AND AGREEMENT NOT TO SUE.** To the maximum extent permitted by law, by signing this application, I hereby release Runway Productions, Inc, The Weinstein Company LLC, Miramax Film Corp., Lifetime Entertainment Services, and Full Picture and each of their affiliated or subsidiary companies, and any television station or channel, cable network, or satellite network that airs the Program, the other contestants and participants in the Program, the advertisers connected with the Program, each of their respective parent, subsidiary and affiliated companies, all other persons and entities connected with the Program, and each of their respective officers, directors, agents, representatives, employees, successors, assignees, and licensees (collectively the

“Releasees”) from any and all claims, actions, damages, liabilities, losses, costs and expenses of any kind (including, without limitation, attorneys' fees) arising out of, resulting from, or by reason of, my participation in or in connection with the Program, including, without limitation, my participation in the contestant selection process of the Program, any exploitation of the Program or my appearance on the Program, the failure of Producer to select me as a contestant, the cancellation of the Program, the recording or use of my Likeness and/or the Materials, or the exercise by Producer of any rights granted by me with respect to the Program on any legal theory whatsoever (including, but not limited to, personal injury, rights of privacy and publicity, false light, and defamation) (the “Released Claims”). The Released Claims specifically include, without limitation, any and all claims, actions, damages, liabilities, losses, costs and expenses of any kind resulting from the actions of another contestant or any other third party at any time. Further, to the maximum extent permitted by law, I agree not to sue Releasees or anyone as a result of the recording or use of my Likeness and/or the Materials (including, without limitation, any claim that such use defames me or invades any right of privacy and/or publicity) or for any cause of action based on any of the Released Claims.

12. Whether or not I am selected to be a contestant on the Program, I shall keep in strictest confidence and shall not disclose to any other applicant, contestant or other third party at any time (i.e., prior to, during, or after the taping or exhibition of any episode of the Program) any information or materials of any kind, including without limitation, any information or materials concerning or relating to Producer or to the Network, the business of Producer or the Network, any program produced by Producer and/or exhibited by the Network, including, without limitation, any information concerning or relating to the Program, the Program applicants, the Program contestants, the location(s) of the Program, the events contained in the Program, or the outcome of any contest in or episode of the Program, that I read, hear or otherwise acquire or learn in connection with or as a result of my applying to be a contestant on the Program or (if I am selected to be a contestant) as the result of my experiences as a contestant on the Program (collectively, the “Information and Materials”). I acknowledge and agree that the Information and Materials are confidential and the exclusive property of Producer and/or the Network. At no time will I ever, directly or indirectly, divulge in any manner or use or permit others to use any of the Information and Materials.

I acknowledge and agree that my obligations with respect to confidentiality set forth in this application shall continue in perpetuity or until terminated by the Network by giving me written notice of termination. In no event will I have the right to terminate my confidentiality obligations under this application. I acknowledge that in the event I breach the confidentiality or any other provisions of this application, my breach may, in the sole discretion of Producer and/or the Network result in my being disqualified to participate as a contestant in the Program. I further acknowledge that a breach by me of any of the confidentiality provisions of this application would cause Producer and/or the Network irreparable injury and damage that cannot be reasonably or adequately compensated by damages in an action at law, and, therefore, I hereby expressly agree that Producer and the Network shall be entitled to injunctive and other equitable relief to prevent and/or cure any breach or threatened breach of any of the confidentiality provisions of this application by me.

I also recognize that proof of damages suffered by Producer and the Network in the event that I breach any of the confidentiality provisions of this application will be costly, difficult, and/or inconvenient. Accordingly, I agree to pay Producer and the Network the sum of One Million Dollars (\$1,000,000.00) per breach plus disgorgement of any past, current or future income that I may or will receive, or have received, in connection with my breach as liquidated damages in the event I

breach any of the confidentiality provisions of this application prior to the initial exhibition of the final episode of the Program. I agree that One Million Dollars (\$1,000,000.00) plus disgorgement of any income that I may or will receive, or have received, in connection with my breach is a reasonable estimate of the amount of damages Producer and the Network are likely to suffer in the event that I breach any of the confidentiality provisions of this application prior to the initial exhibition of the final episode of the Program, considering all of the circumstances existing as of the date of this application. In addition, I agree to pay Producer and the Network the sum of One Hundred Thousand Dollars (\$100,000.00) per breach plus disgorgement of any income that results from my breach as liquidated damages in the event I breach any of the confidentiality provisions of this application after the initial exhibition of the final episode of the Program. I agree that One Hundred Thousand Dollars (\$100,000.00) plus disgorgement of any income is a reasonable estimate of the amount of damages Producer and the Network are likely to suffer in the event I breach any of the confidentiality provisions of this application after the initial exhibition of the final episode of the Program, considering all of the circumstances existing as of the date of this application.

13. I acknowledge, understand and agree that if any dispute, controversy or claim arising out of or relating to this Agreement, the breach of any term hereof, or any effort by any party to enforce, interpret and/or construe, rescind, terminate or annul this Agreement, or any provision thereof, including without limitation the applicability of this arbitration provision, and any and all disputes or controversies relating in any manner to my application for, appearance on, or participation in the Program if I am selected (collectively "Matter(s)"), cannot be settled through direct discussions, the parties agree to endeavor first to settle the controversy or claim by mediation conducted in the County of Los Angeles and administered by JAMS under its Commercial Mediation Rules. If any Matter is not otherwise resolved through direct discussions or mediation, it shall be resolved by confidential binding arbitration conducted in the County of Los Angeles, and administered by JAMS in accordance with the commercial arbitration rules of JAMS (the "JAMS Rules"). My remedies for any breach of this Agreement by Producer or others will be limited to a binding arbitration seeking recovery of actual monetary damages, if any, and in no event will I be entitled to rescind this Agreement or seek or obtain injunctive or any other equitable relief or otherwise enjoin or prevent the exploitation of any of the rights I have granted herein, or any award of punitive damages, nor shall I have any right to terminate this Agreement or any portion thereof, or rescind any rights that I have granted hereunder.

15. This Agreement cannot be changed, amended, modified or terminated except in writing signed by Producer and me. Any waiver of any term of this Agreement in a particular instance shall not be a waiver of such term for the future. I agree that the invalidity or unenforceability of any part of this Agreement shall in no way affect the validity or enforceability of any other part thereof. All remedies, rights, undertakings, obligations, and agreements contained in the Agreement shall be in addition to and shall not limit any other remedy, right, undertaking, obligation, or agreement of either party.

16. I agree that Producer may license, assign, and otherwise transfer this application and all rights granted by me under this application to any person or entity.
