Darcy J. Davis, Chief Executive Officer, HEALTH CARE DISTRICT OF PALM BEACH COUNTY

Darcy J. Davis is the Chief Executive Officer of the Health Care District of Palm Beach County and its subsidiary operations. The Health Care District is a diverse and complex public health care system encompassing a nationally-recognized trauma system, a skilled nursing facility, a rural teaching hospital, school-based health clinics, pharmacies, primary care and dental clinics, and health coverage for the uninsured. Ms. Davis was named CEO in February 2016.

Ms. Davis joined the Health Care District in July 2011 and has served in several roles of increasing responsibility, including Chief Financial Officer/Chief Operating Officer, prior to her promotion to the top executive role. Prior to joining the District she served in executive level positions including Senior Vice President and Chief Financial Officer for a complex academic medical center and she has held other key financial and operational roles over her 25 years in the healthcare industry.

Ms. Davis serves as a member of the county's Heroin Task Force and Sober Home Task Force. She also serves on America's Essential Hospitals' Strategic Planning Committee, the Board of Directors of the Southeast Florida Behavioral Health Network, and the Board of Directors of the South Florida Hospital and Healthcare Association. She has been recognized by the South Florida Business Journal in 2016 as a Power Leader in Healthcare and in 2017 as one of South Florida's Most Influential Executives. During her tenure as CEO, the District's primary care clinics received national recognition for its innovative approach to achieving a colorectal cancer screening rate that is twice the national average for community clinics. Also under her leadership, the District's nursing home garnered 5-star quality ratings from the Centers for Medicare and Medicaid Services as well as U.S. News & World Report.

Ms. Davis earned her BBA in Accounting from Mercer University and her MSM in Healthcare Administration from Troy State University. She is a Certified Public Accountant in Georgia. Her nursing home administrator license from New Mexico is inactive.

Thomas Cleare, VP of Strategy, HEALTH CARE DISTRICT OF PALM BEACH COUNTY

Thomas Cleare is the Health Care District of Palm Beach County's Vice President of Strategy. Dr. Cleare is responsible for the District's system-wide strategic planning process for the diverse safety-net programs serving the residents of Palm Beach County including the nationally-recognized trauma system, a skilled nursing facility, a rural public hospital, school-based health clinics, pharmacies, primary care and dental clinics and health coverage for the uninsured.

In addition, Dr. Cleare leads the District's community partnership funding activities and giving programs, records and governance management, facilities management, legislative support, provider network management and reimbursement, and utilization and care coordination management.

Dr. Cleare joined the Health Care District in October 2003 and has served in a variety of positions including Director of Research and Planning and Chief Program Officer. Prior roles included responsibilities for directing the operational functions of the District's health coverage programs that included the Personal Health Plan Medicaid HMO, the Coordinated Care indigent care program, the Vita Health shared premium program and the Maternity Care Program.

Prior to joining the Health Care District, Dr. Cleare served in a variety of leadership roles with a national managed care specialty provider network. Dr. Cleare has also served as an Adjunct Faculty member at Florida Atlantic University.

Dr. Cleare has over 20 years of experience in health care operations, managed care, and health policy. Dr. Cleare is the author of two non-fiction books, Establishing a Healthcare Emergency Response Coalition and An Analysis of Accountability in Public – Private Health Care Programs Serving Vulnerable Populations, and one fiction book, Treasure in Paradise, and has written several articles and conference papers related to health care, emergency preparedness, and local government policy. Dr. Cleare received a Doctor of Philosophy and Master of Business Administration from Florida Atlantic University. He also holds a Bachelor of Science from the University of Florida.

Christopher Irizarry, VP & Exec Dir of Clinic Services, HEALTH CARE DISTRICT OF PALM BEACH COUNTY

Christopher F. Irizarry, MPA, is an officer with the Health Care District of Palm Beach County, a diversified, public safety net health care system ensuring residents of Palm Beach County, Fla. have access to health care services. Mr. Irizarry joined the Health Care District in 2013 as its FQHC Executive Director, responsible for the overall administrative and regulatory leadership of the C. L. Brumback Primary Care Clinics, Federally Qualified Health Centers that are owned and operated by the Health Care District.

Under his leadership, the Brumback Clinics have expanded growth from four to nine sites throughout the county, including a primary care clinic at the county's homeless resource center, a primary care clinic at a behavioral health center in West Palm Beach and a public school-based clinic at Palm Beach Lakes Community High School in West Palm Beach that provides medical services to the students who attend the school.

In addition to the Brumback Clinics, Mr. Irizarry's oversight includes the Health Care District's School Health Program, which staffs more than 200 Registered Nurses in the county's public schools, and the District's Pharmacy Program, which are co-located in five of the Brumback Clinics. The Health Care District also operates a trauma system, an acute-care rural hospital, a skilled nursing facility, and health coverage programs for eligible, uninsured county residents.

Under Mr. Irizarry's leadership, the Brumback Clinics offer compassionate, comprehensive medical and dental services to all adults and children, with or without insurance. The Brumback Clinics also offer financial counseling, social services, health care for the homeless and migrant workers, and help for uninsured patients to apply for health coverage. The Brumback Clinics are located in Belle Glade, Delray Beach, Lake Worth, Lantana and West Palm Beach. For calendar year 2016, the Brumback Clinics had 36,509 unduplicated patients, 100,826 encounters and 12,853 unique dental patients.

Prior to joining the Health Care District, Mr. Irizarry served for seven years as the President and CEO of the North Hudson Community Action Corporation in Union City, New Jersey, the largest FQHC in the State of New Jersey. Mr. Irizarry received a Bachelor of Science in Administration of Justice from Rutgers University and a Master of Public Administration from City University of New York.

Owen O'Neill, Clinics Can Help

Owen O'Neill has been a Registered Nurse in the State of Florida for over twenty years. He founded Clinics Can Help in 2005 by collecting and donating medical equipment in his spare time. After years of hard work as the its Executive Director, he has built Clinics Can Help into a thriving not-for-profit agency that assists over to 2,300 clients annually by donating more that over \$900,000 worth of medical equipment and supplies to local children and adults in need.

Delray Beach Mayor Cary Glickstein
